

THE FEEDBACK PROCESS

Feedback on curriculum from the different stakeholders is obtained. It is a continuous process so that the corrective action may take well on time. The process of feedback involves the following steps:-

DRAFT THE FEEDBACK FORM: Drafting the feedback is one of the first step in the process to capture the relevant data on curriculum. This is re-occurring process, which include revising of the feedback form so as to accommodate the changing need of the curriculum.

DISTRIBUTE TO CONCERNED STAKEHOLDER: The form is distributed to relevant stakeholders from library/administrative office.

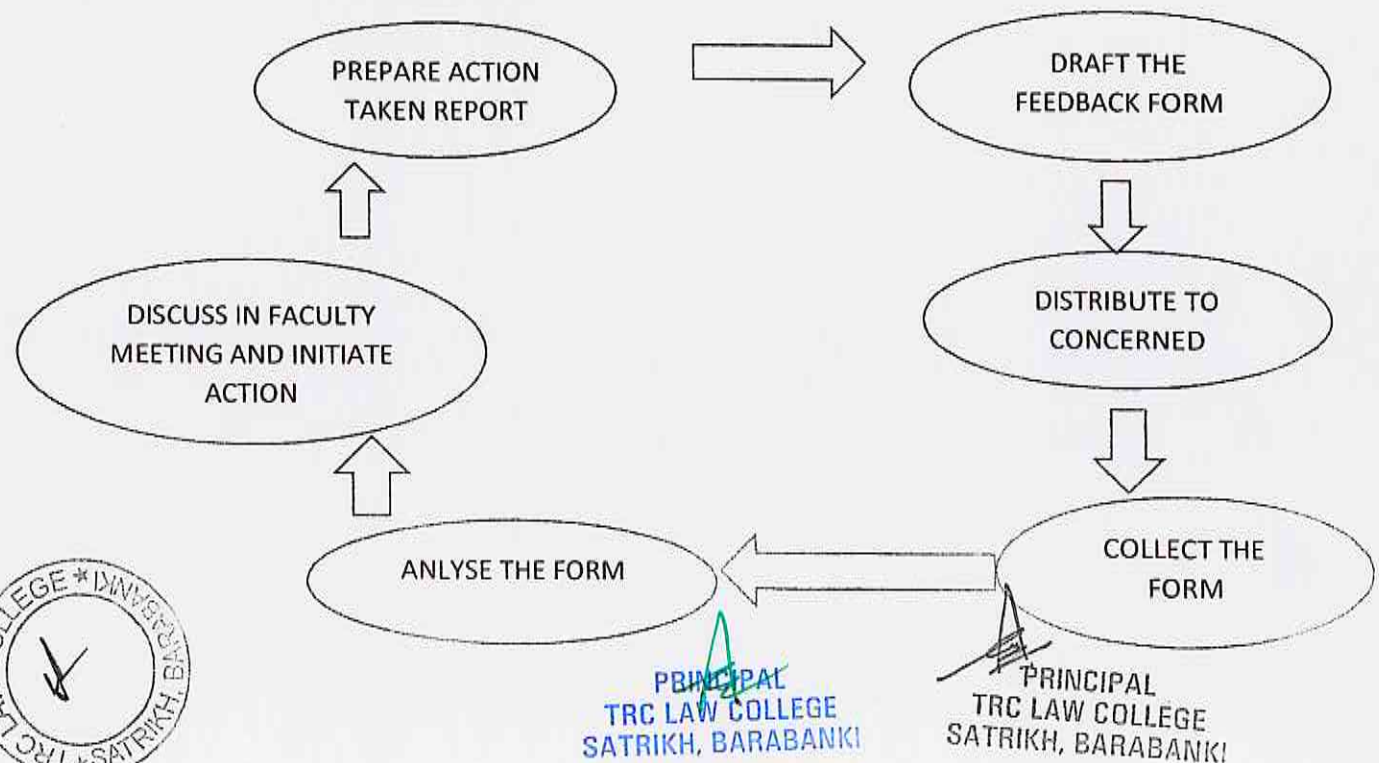
COLLECT THE FORM: The feedback form thus collected from the concerned stakeholders.

ANLYSE THE FORM: After that the feedback forms are analyzed and important suggestions are noted.

DISCUSS IN FACULTY MEETING AND INITIATE ACTION: Then the analysis report and the suggestions made in the feedback forms are discussed in the faculty meeting and concern persons are instructed to take appropriate action.

PREPARE ACTION TAKEN REPORT: Finally the implementation of the instructions are noted in the form of action taken report.
