

PROCEDURE FOR THE REVALUATION OF THE ANSWER-BOOK/S

The following procedure will be followed for Revaluation process after the end semester examinations:

1. A student can apply online on RMLAU, Ayodhya website <http://www.rmlau.ac.in> for revaluation and challenged by clicking on "Apply, View copy & challenge form" his/her answer-scripts of all the papers, he/she appeared for theory examinations, except practical paper, within prescribed duration as instructed by the University after publication of the result, on payment of a prescribed fee as per the procedure notified by the Controller of Examinations in each semester.
2. Applying for Xerox copy of the answer book and applying for Revaluation will be two independent processes.
3. Applying for the Xerox copy of the answer book shall not be a pre-requisite for applying for revaluation of the answer book in the said subject.
4. The students have to record, within prescribed time period as instructed by the University after publication of the result, on payment of a prescribed fee as per the procedure notified by the Controller of Examinations in each semester.
5. The students will be allowed, as per the schedule published by the Controller of Examinations, to go through their answer-scripts. Students can record their appeals, if any, in the prescribed form after viewing the marks awarded.

6. Controller of Examinations will organize to address the appeals. Change in marks, if any, will be updated in the results and the revised results will be published.
7. This revaluation facility shall be for theory papers only. The revaluation of answer book shall not be permitted in respect of the marks awarded to the scripts of viva-voce/practical examination.
8. The non-refundable prescribed fees per answer book for the purpose of revaluation shall be paid by the student/examinee. The said fee shall be remitted by online mode.
9. The prescribed application form for revaluation of answer book duly filled by the applicant examinee only is to be submitted along with the statement of marks, prescribed fees as above and question paper/s for which he/she intends to apply for revaluation, within prescribed time duration as instructed by the controller of the examination after the declaration of the result of the respective examination.

विश्वविद्यालय की वार्षिक एवं सेमेस्टर परीक्षाओं में उत्तर पुस्तिकाओं की संख्या अत्यधिक होने के कारण उत्तर पुस्तिकाओं की गुणवत्तापरक मूल्यांकन सम्बन्धी प्रत्यावेदन, परीक्षाफल निर्माण त्रुटिपूर्ण होने तथा उत्तर पुस्तिकाओं की स्कूटनी हेतु बहुतायत में छात्रों के आवेदन पत्र प्राप्त होते हैं। विश्वविद्यालय में केन्द्रीय रूप से कतिपय कोडेड एवं अधिकांशतः सामान्य प्रक्रिया के अन्तर्गत उत्तर पुस्तिकाओं के मूल्यांकन कराये जाने की व्यवस्था वर्तमान में प्रचलित है। मूल्यांकन की सतत गुणवत्ता सुनिश्चित किये जाने हेतु मूल्यांकनकर्ताओं में मूल्यांकन कार्य के प्रति संवेदनशीलता एवं उत्तरदायित्व बढ़ाया जाना नितांत आवश्यक है। उक्त के अतिरिक्त छात्रों द्वारा समय-समय पर मूल्यांकित उत्तर पुस्तिकाएं आर.टी.आई के अन्तर्गत भी उपलब्ध कराये जाने हेतु आवेदन पत्र प्राप्त होते हैं, छात्रों को आर.टी.आई/स्कूटनी के अत्रतगत उपलब्ध करायी गयी उत्तर पुस्तिकाओं में अनेकों ऐसे प्रकरण प्रकाश में आये हैं, जिनमें छात्रों ने मूल्यांकनकर्ता/शिक्षकों द्वारा किये गये अंको पर असतोष व्यक्त किया है तथा मूल्यांकनकर्ता से इतर विषय विशेषज्ञों का अभिमत प्राप्त करने पर यह पाया गया है कतिपय मूल्यांकनकर्ताओं द्वारा न्यायसंगत मूल्यांकन नहीं किया गया है। विश्वविद्यालय में उत्तर पुस्तिकाओं के पुनर्मूल्यांकन की व्यवस्था न होने तथा समुचित मूल्यांकन न होने के कारण अनेकों प्रकरणों में परीक्षार्थियों/छात्रों का अहित हो जाता है। उपरोक्त तथ्यों के दृष्टिगत छात्रहित में उत्तर पुस्तिका के अवलोकन के उपरान्त मूल्यांकन से असन्तुष्ट छात्रों को चैलेंज इवैलुवेशन (मूल्यांकन को चुनौती) का अवसर प्रदान किये जाने की व्यवस्था निम्नानुसार प्रस्तावित की जाती है:-

1. छात्र जनसूचना का अधिकार अधिनियम-2005 के अन्तर्गत उत्तर पुस्तिका अवलोकित कराये जाने की प्रक्रिया का अनुसरण करते हुए मूल्यांकित उत्तरपुस्तिका की स्कैन्ड कापी प्राप्त करेगा।
2. उत्तर पुस्तिका के अवलोकन से असन्तुष्ट छात्र उत्तर पुस्तिका प्राप्ति की तिथि से 15 दिन के अन्दर रू० 3000/- प्रति प्रश्नपत्र की दर से देय शुल्क का भुगतान कर चैलेंज इवैलुवेशन के लिए आवेदन कर सकेगा।
3. सम्बन्धित उत्तर पुस्तिका का मूल्यांकन मूल मूल्यांकनकर्ता से इतर माननीय कुलपति जी द्वारा नामित दो चैलेंज मूल्यांकनकर्ताओं द्वारा अलग-अलग कराया जायेगा तथा दोनों मूल्यांकनकर्ताओं द्वारा प्रदत्त अंको का औसत चुनौती देने वाले छात्र को प्रदान किया जायेगा।
4. यदि मूल मूल्यांकनकर्ता द्वारा प्रदान किये गए अंको तथा दोनों चैलेंज मूल्यांकनकर्ता द्वारा किये गये अंको के औसत का अन्तर प्रश्नपत्र के अधिकतम प्राप्तांको के 15: तक पाया जायेगा तो मूल मूल्यांकनकर्ता द्वारा प्रदान किए गये अंको में परिवर्तन नहीं किया जायेगा तथा छात्र द्वारा जमा धनराशि जब्त कर ली जाएगी।
5. यदि मूल मूल्यांकनकर्ता द्वारा प्रदान किए गये अंको तथा चैलेंज मूल्यांकनकर्ताओं द्वारा दिये गये अंको के औसत का अन्तर प्रश्नपत्र के अधिकतम प्राप्तांको के 15: से अधिक एवं 25: तक पाया जाएगा तो मूल मूल्यांकनकर्ता द्वारा प्रदान किए गए अंको को दोनों चैलेंज मूल्यांकनकर्ताओं द्वारा दिए गए अंको से बदल दिया जाएगा। ऐसी स्थिति में छात्र द्वारा जमा शुल्क रू० 500/- की कटौती कर शेष राशि उसे वापस कर दी जाएगी तथा मूल्यांकनकर्ता के खिलाफ विश्वविद्यालय द्वारा चेतावनी दी जा सकती है।
6. यदि मूल मूल्यांकनकर्ता द्वारा प्रदान किए गए अंको तथा दोनों चैलेंज मूल्यांकनकर्ताओं द्वारा दिये गये अंको के औसत का अन्तर प्रश्नपत्र के अधिकतम प्राप्तांको के 25: से अधिक पाया जाएगा तो ऐसी उत्तर पुस्तिका को माननीय कुलपति जी द्वारा नामित तृतीय चैलेंज मूल्यांकनकर्ता से मूल्यांकित कराया जाएगा। मूल मूल्यांकनकर्ता द्वारा प्रदान किए गए अंको को तीना चैलेंज मूल्यांकनकर्ताओं द्वारा दिए गये अंको के औसत से बदल दिया जायेगा। ऐसी स्थिति में छात्र द्वारा जमा शुल्क से रू० 500/- की कटौती कर शेष धनराशि उसे वापस कर दी जायेगी तथा मूल मूल्यांकनकर्ता के खिलाफ विश्वविद्यालय द्वारा कठोर कार्यवाही की जा सकती है।

PASS PERCENTAGE & PROMOTION CRITERIA

1. The minimum marks required to pass any paper in a semester shall be 36% in theory and 45% in Practical, wherever applicable. The student must secure 45% in the total of End Semester Examination.
2. A student shall be eligible for promotion from 1st year to 2nd year of the course provided she/he has passed at least 8 papers of the LL.B. taken together with aggregate of 45% marks.
3. A student irrespective of semester 1st, 3rd, 5th semester results shall be eligible for promotion to 2nd, to 4th, 6th semester respectively.
4. Students who do not fulfill the promotion criteria shall be declared fail in the semester concerned. However, they shall have the option to retain the marks in the papers in which they have secured Pass marks.
5. A student who has to reappear in a paper prescribed for Semester I/III/ V may do so only in the Semester examinations to be held in December. A student who has to reappear in a paper prescribed for Semester II/IV/VI may do so only in the examination to be held in May.

REAPPEARANCE/BACKPAPER IN PAPERS

1. A student may reappear in any theory/practical paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (for example, a student reappearing in a paper prescribed for Semester I examination, may do so along with subsequent Semester III examination and not along with papers for Semester V).
2. A candidate who has not cleared the papers of Part III (V & VI Semesters) may reappear in any paper of V or VI Semester, at the immediate subsequent examination on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period (i.e. 6 year from the date of admission). (Note: The candidate of this category will not be allowed to join any postgraduate courses).
3. In the case of reappearance in a paper, the result will be prepared on the basis of candidate's current performance in the examination.
4. In the case of a candidate, who opts to re-appear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to re-appear shall not be taken into account while determining her/his result of the examination held currently. She/he will be treated as failed.
5. Reappearance/back paper in Practical examinations can be allowed.

DIVISION CRITERIA

A student who passes all the papers of LL.B. Programme prescribed for Semester I to Semester VI examinations would be eligible for the degree. Such a student shall be categorized on the basis of the Combined result of Semester I to Semester VI examinations as follows:-

60% or more	First Division
45% or more but less than 60%	Second Division
Less than 45%	Fail

PASS PERCENTAGE & PROMOTION CRITERIA

1. The minimum marks required to pass any paper in a semester shall be 36% in theory and 45% in Practical, wherever applicable. The student must secure 45% in the total of End Semester Examination.
2. A student shall be eligible for promotion from 1st year to 2nd year of the course provided she/he has passed at least 7 papers of the B.A.LL.B. I and II Semester taken together with aggregate of 45% marks.
3. A student irrespective of semester 1st, 3rd, 5th, 7th, 9th semester results shall be eligible for promotion to 2nd, 4th, 6th, 8th, 10th semester respectively.
4. Students who do not fulfill the promotion criteria shall be declared fail in the semester concerned. However, they shall have the option to retain the marks in the papers in which they have secured Pass marks.
5. A student who has to reappear in a paper prescribed for Semester I/III/V/VII/IX may do so only in the Semester examinations to be held for ODD semester. A student who has to reappear in a paper prescribed for Semester II/IV/VI/VIII/X may do so only in the examination to be held for EVEN semester.

REAPPEARANCE/BACKPAPER IN PAPERS

1. A student may reappear in any theory/practical paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (for example, a student reappearing in a paper prescribed for Semester I examination, may do so along with subsequent Semester III examination and not along with papers for Semester V).
2. A candidate who has cleared the papers of Part V (IX & X Semesters) may reappear in any paper of IX or X Semester, at the subsequent examination on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period (i.e. 10 year from the date of admission). (Note: The candidate of this category will not be allowed to join any postgraduate courses).
3. In the case of reappearance in a paper, the result will be prepared on the basis of candidate's current performance in the examination.
4. In the case of a candidate, who opts to re-appear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to re-appear shall not be taken into account while determining her/his result of the examination held currently. She/he will be treated as failed.
5. Reappearance/back paper in Practical examinations can be allowed.

DIVISION CRITERIA

A student who passes all the papers of B.A.LL.B. programme prescribed for Semester I to Semester X examinations would be eligible for the degree. Such a student shall be categorized on the basis of the Combined result of Semester I to Semester X examinations as follows:-

60% or more	First Division
45% or more but less than 60%	Second Division
less than 45%	Fail
