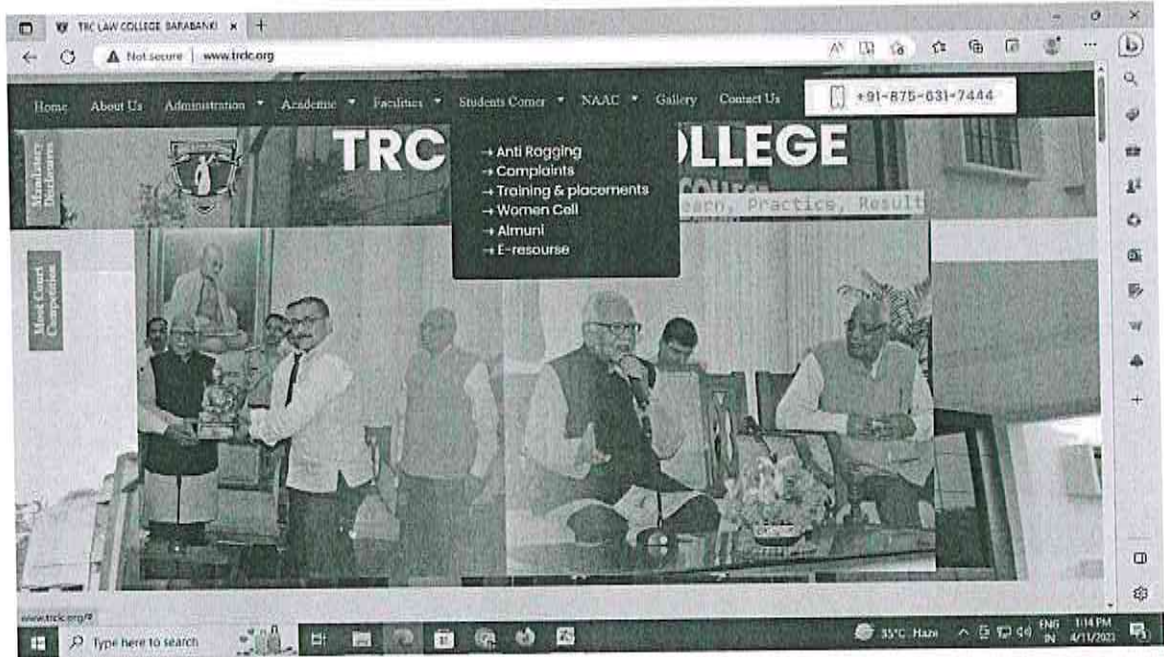



## Report of the Meeting conducted on 20<sup>th</sup> April 2019: Anti-Ragging & Student Grievance Redressal Committee
