Governing Body Organogram



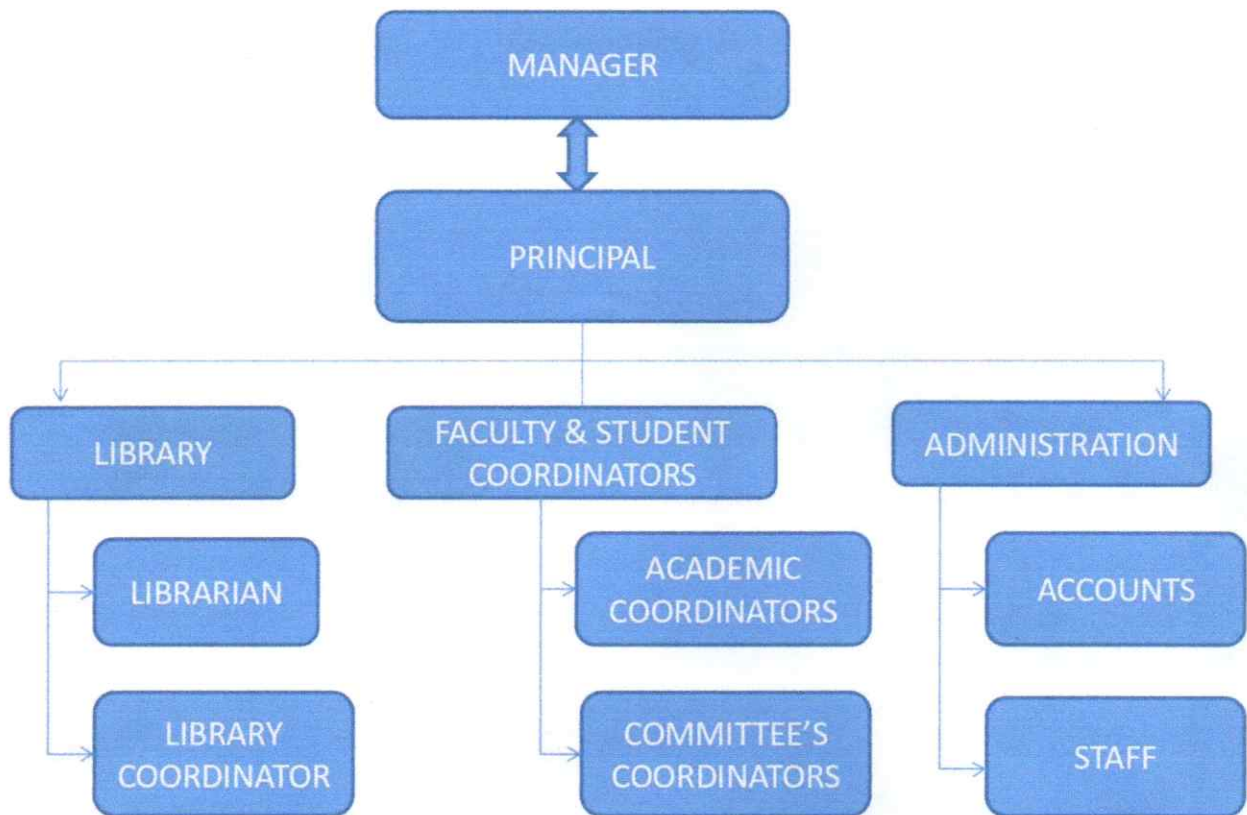
