- 4. Responsibility of the Husband: The lecturer emphasized that the husband is responsible for providing maintenance to his divorced wife during the Iddah period, including food, shelter, and clothing.
- 5. Role of the Community: The lecturer highlighted the importance of the community in providing support to divorced women, particularly in cases where the husband is unable or unwilling to provide maintenance.
