Sub: Extension approval of affiliation of T.R.C. Law College,
Barabanki, UP for imparting three year law course.

Sir,

Legal Education Committee at its meeting held on 24th August, 2013 considered the inspection report of the above mentioned college. After consideration, Committee made the following recommendations:-

The Legal Education Committee has considered the recommendations of the Standing Committee. After consideration, the Committee is of the view that T. R. C. Law College, Barabanki, Uttar Pradesh be granted extension of approval of affiliation for imparting three year LLB course from the academic year 2012-13 to 2014-15 with four sections of 60 students in each section subject to following conditions:

Further the Committee seeks, whether in the list of faculty at Sl. No.1 Dr. Yashwant Singh posses master degree in law or not, the same should be specified through affidavit. The Committee also finds in the list that persons mentioned at Sl. No.11 to 13 are only having LL.B degree, not having master degree in law, so they are not competent to teach law as per the Rules of Legal Education-2008. It is also seen that the college has admitted 80 students and tendered unconditional apology, which is accepted subject to the decision of the Legal Education Committee in the year 2009, where it is resolved, if the college has 80 students in one section as per Rule they can admit 60 students in one section and 20 students in another section.

1. The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal-Education Rules - 2008.
2. College should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.

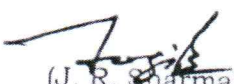
3. The institution is directed to upgrade the library by investing Rs. 50,000/- per year.
4. Teacher Student ratio shall be 1:40.
5. The institution shall also subscribe books and law journals of AIR including its CDs and online material as per the decision of the Council.
6. College should purchase and install 15 more computers along with internet and database facility.

The institution should submit affidavit in the compliance to the above conditions within six weeks.

The above recommendations were considered by the Bar Council of India at its meeting held on 24th August, 2013 and accepted the same.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2014 failing which a late fee will be charged.
