'Ordinance and General Rules of Diploma Program Courses'

In the reference of letter issued by the University Grants Commission, New Delhi vide letter No. F.2- 10/2023(AC-Policy) dated 09.09.2024, in compliance and consequences of that, the Executive Council of Dr. Ram Manohar Lohia Awadh University, Ayodhya has decided and permitted the college vide letter no. लो.अ.वि./सम्ब०/23727/2024 दिनांक 08.10.2024 to run the session as per the provisions for higher education of a University Grant Commission under the autonomous status.

According to THE GAZETTE OF INDIA: EXTRAORDINARY No. CG-DL-E-05042023-244940, PART-III, SECTION-4, No.222, Dated 03.04.2023, Para 10.1, the Autonomous college can run the Diploma Courses after fulfilling the necessary compliance and approval from the Academic Council and BoS, the College will start the Diploma Courses in Human Rights, Consumer Protection, Intellectual Property Rights, and Cyber Law after fulfilling all the necessary approval and directives.

Whereas, this ordinance shall be implemented and enforced from the session 2025-26.

INTRODUCTION:

TRC LAW COLLEGE situated in Satrikh, stands as a distinguished institution of higher education in Law within the Barabanki Region of Uttar Pradesh, established in 2007.

TRC Law College is the First Law Institute of Barabanki district and is committed to build better character and a better human being. The foundation of TRC Law College was laid keeping in mind the future prospects of the district and in the vicinity. The main purpose of the college is to spread awareness among the students about the world beyond their limited arena. To strive and not to give up, to battle on for removing ignorance, poverty, illiteracy and fragmentation of society; should be their constant goal like the North Star.

The programmes at T R C Law College are designed to offer courses tailored to the needs and aspirations of students, providing them with enriched personalized learning experiences. The details of the Diploma Program are mentioned here and will be governed through this ordinance.

1. TITLE:

This Academic Ordinance will Governs the Diploma programmes in: Human Rights, Consumer Protection, Intellectual Property Rights, and Cyber Law of TRC Law College, Satrikh, Barabanki.

i. This Ordinance may be called The Academic Ordinance for Diploma Programmes 2025-26 of TRC Law College (applicable from the Academic year 2025-26 respectively). This Ordinance apply to Full-Time students of Diploma Program.

A student who has been duly admitted to the TRC Law College Programs and has registered for and attended a Program of study is referred to as an enrolled student of the Program.

- iii. Skill development and holistic multi-disciplinary learning are the focus and the same is incorporated within the different Programs of Study at TRC Law College and the ordinance is framed accordingly.
- iv. BoS with inputs from the Academic Council would design the curriculum of different programmes of Diploma Courses as per the guidelines after fulfilling the necessary requirements for the courses.
- v. Faculty members are encouraged by the BoS to design courses having components of job oriented skills. They are also encouraged to adopt innovative methods of Teaching Learning to impart the same and to have suitable assessment practices.
- vi. It is suggested that all Faculty should network with Law Firms/ Departments which deal with Legal Affairs, including the Legislative Department and Department of Justice (who manages justice administration) /Academic Institutions for facilitating student internships.
- vii. This ordinance will come into force with effect from the date of approval of the Academic Council and from the academic year 2025-26 onwards.

2. SCOPE:

- i. This ordinance shall apply to Diploma program of TRC Law College, Satrikh under UGC w.e.f. the Academic Session 2025-26.
- ii. The duration of the program for the award of Diploma in Discipline will be one academic year.

3. ELIGIBILITY CRITERIA FOR DIPLOMA COURSES ARE AS FOLLOWS:

- The students who have passed the XII std. examination of U.P. State Board of Higher Secondary Education, Central Board of Secondary Education, Indian School Certificate (12th) Exam or any other board recognized by the government but for diploma in cyber law the eligibility criteria is student passed to required 10+2 science stream from a recognized board.
- The candidate must minimum score 50% for 10+2 for admission in Diploma Course for all categories (GEN/OBC/SC/ST).

4. GENERAL RULES REGARDING ADMISSION:

- The admission will be based either on Entrance Examination or Merit Basis, as decided by the college.
- The Candidate must produce their Educational Documents and other relevant documents at the time of counselling/admission.
- Students who choose to pursue a Diploma have to meet the requirements of the college.
- Admission is determined on entrance examination/merit. Students should have earned
 the required aggregate percentage of marks in their Higher Secondary
 School/Intermediate (10+2) or equivalent from a recognized board.
- For Diploma Course student may apply online/offline.
- The Start Date and End Date, Names of the Selected Students and Batch information for the admission form will be made available.

5. COURSE OF STUDY:

- In each diploma program candidate have to study Five (05) compulsory papers including project work and viva-voce.
- There shall be teaching for 30 weeks (180 Days) in Academic Year excluding admission and examination.
- In case of extreme emergency or conditions where the routine counduct of 90 days seems difficult due to law and order conditions, weather emergency, pandemic conditions the loss will be covered through special teaching hours conducted through online mode.
- The Diploma Program Session will be from August to May in each Academic Year.
- The medium of instruction for the Diploma Courses shall be Hindi/English. Instructions in all Diplomas shall consist of lectures and tutorials.
- The Candidate of Diploma Program shall be required to pass in all the prescribed courses within the span of Two (02) Years from the academic session of his/her admission in the said course.
- The Curriculum of study for the Each Diploma Program shall comprise of the courses set out in the Schedule A.

6. EXAMINATION:

- This program is regular program and student attendance must be 75% to appear in the examination. The aforesaid attendance may be reduced up to 10% on recommendation of the Principal on health ground or any other reasonable causes. In case of health issue the candidate must produce the certificate from any registered medical practitioner or from Government Hospital authority.
- The examination shall be conducted once in a year i.e. in May only.
- A candidate must pass in all papers with minimum 45% marks in each paper and aggregate 50% marks for passing the Diploma Program.
- Each Diploma Program will include four written Papers and Project work with Viva-Voce.
- Each paper will be divided into Theory (80 Marks) and Internal Assessment (20 Marks Total of 100 Marks. Theory papers will be divided into three parts: Long Questions, Short Questions, and Very Short Questions. The candidates have to answer the long, short, and very short questions in 600 words, 300 words, and 100 words respectively
- The exam duration of each paper will be of Three Hours.
- The Project work will be assigned by the HoD of Diploma Program and must be completed before the examination and will be submitted to the HoD. The Project work and Viva-Voce shall carry 100 Marks.

7. STANDARD OF PASSING

- To pass the Diploma Course a candidate shall obtain 45% of marks in each paper and aggregate 50% marks will be declared to have passed the Diploma Program.
- A candidate who is securing >= 60% of the total marks will be declared to have passed the Diploma Program in First Class and the candidate who is securing >=50 and <60% of the total marks will be declared to have passed the Diploma Program in Second Class.

8. SUPPLEMENTARY EXAMINATION:

- Those candidates who have failed in any paper of the examination may appear in the supplementary examination.
- The supplementary examination will be held after 60 days from the declaration of the Result.
- The candidate can appear only for the Two Papers in the Supplementary examination.
- The candidate who has appeared in the main examination of the said course can only be eligible for the Supplementary Papers.

Maximum Two Chances will be given for the supplementary papers.

9. EXEMPTION:

- If a candidate has obtained one of the four Diploma and wishes to appear at any of the remaining three Diplomas, he may be allowed to claim exemption in General English Paper. A candidate claiming such exemption will not be eligible for the award of the class prizes etc. This exemption will be valid only for three year after the completion of the diploma course.
- If any student fails to appear in the main examination of the said course due to reasonable reasons with proper evidence, he/she may be granted an extension of one year only as an Exempted Candidate. This extension can only be granted just after the expiry of the maximum span of the course, as defined in the ordinance to pass the said course, and upon the approval of the Principal of the college.

10. MISCELLANEOUS PROVISIONS

- 1. These Ordinances contained herein shall be deemed to have come into effect from the academic session 2025-26 to the extent of its applicability.
- 2. The Principal of the College in consultation with the Head of the Diploma Program shall have the power to remove all difficulties in interpretation and/or application of these Ordinances, which shall be final.
